#### Ms. Vee

- The re-enrollment process for current students is taking place January 11th February 5th.
  - This is being done digitally via DocuSign.
  - Families will submit the re-enrollment form online and will be required to attach their driver's license and 1 form of proof of residency.
- The only way a parent can enroll their student's sibling is if they apply through the lottery (this is different from last year).
  - This is because we changed our re-enrollment forms to use "initial charter school enrollment forms", which don't have the option of asking parents if they want to enroll a sibling of their current VACS student.
- The Open Houses will take place *virtually* on January 14th (6PM) and February 6th (2PM).
  - Open Houses include a short asynchronous video, followed by Q&A.
- The lottery will take place *virtually* on February 18, 2021 (5PM).

#### **Mr.G:- Director of Instruction**

- Quarter 2 "at risk of failure" notices were sent to families before the end of Quarter 2 (an early heads up).
- Report cards for Quarter 2 are virtual this year (accessed through Infinite Campus), but families can still request a hard copy from Ms. Vee.
- The Teacher Induction Program is still continuing for teachers seeking certification.
  - By the end of January, we will meet our minimum requirements for this program.
  - We will continue having these induction meetings for two more months for the book study sessions.
- We want to finalize our observations by January 22nd.
- WIDA testing has begun for ESL.
- The 2nd round of iReady testing will take place January 19th February 9th to see if students are growing and making progress.
- We are still planning and preparing for PSSAs.
  - Classroom teachers are integrating PSSA Prep in their classes weekly.
- Intervention teachers are continuing to meet with MTSS students on a regular basis at most grade levels.

## **Covid Updates**

- 4,000 overall deaths in the U.S. per day (as of today).
- Deaths per day have almost doubled since the beginning of the pandemic.
- Data suggests more positive cases and deaths than the fall.
- 4 staff members so far have informed us that they have tested positive since the pandemic.
- ALL families survey (150 families responded) 43% (in-person) vs. 57% (online).

- SPED families survey 35% (in-person) vs. 65% (online).
- The plan is that we will conduct 100% virtual learning for all regular education students and offer a hybrid model for SPED & ELL students starting Feb 1st until we reconsider this in the February meeting.

## **New Staff Hires**

• Gideon Luzares (7/8th Math Intervention) has been re-hired, and Kelli Crossin (3rd Grade Classroom Teacher) and Krystina Heidelberg (7/8th ELA) have been newly hired.

#### Other

- Ms. Connie Monk is the new President of the Vision Academy Parent Partners (VAPP).
- A guest speaker will be talking about civil rights and social justice with students for Black History Month via Zoom in February.

## **OPPS Team / Financial Updates – Ali & Chinar**

- As of December 21st, our assets are sufficient to meet our current liabilities.
- Our local revenue is 55% of our budget revenue.
- We paid DCIU \$120,000 for speech therapy and occupational therapy for the previous academic year. They haven't billed us for this year yet.
- Accounts receivable summary: WPSD owes us about \$323,000 for this month. We will be receiving this money on January 23rd. Southeast Delco owes us \$90,000, and Philadelphia and Upper Darby owe us \$11,000.
