- Financial Statements (Exhibit II)
- As of October 31, there was \$481,043 in cash and a current ratio of 2.24 (benchmark = 2). Current year school district receivables are at \$942,754. Cash on hand is at 10.49 days.
- On October 31 (approximately 30% of the way through the fiscal year), we recognized 32% of budgeted revenue and 31% of budgeted expenses (per the 23-24 budget), resulting in a net gain of \$91,106.
- School district revenue is coming in at 30% of budgeted revenue. Projections will resume in November.
- William Penn School District has significantly fewer students than what was budgeted, amounting to \$453,167 less revenue. Per Pupil Funding from William Penn has also gone dove about \$1500/student in comparison to last year.
