  - We received the draft audit, which will be shared with board members before the next meeting.
  - Currently, school district receivables stand at \$183,741, with cash on hand totaling 13.81 days.
  - As of December 31 (approximately 50% of the way through the fiscal year), we recognized 48% of budgeted revenue and 53% of budgeted expenses according to the 23-24 budget. School district revenue is currently at 46% of budgeted revenue.
  - Per pupil funding from William Penn School District has significantly gone down, resulting in less projected revenue.
  - As of December 31, we had \$1,100,788 in cash. However, we recently paid \$400K for change orders on the 171 Penn Blvd building construction, reducing our cash.
