- 6. General Information Form (Employee/Contractor)
- 7. IRS Form W-4
- 8. Direct Deposit Information
 - Direct Deposit Form
 - Voided Check or Bank-issued Direct Deposit Form
- 9. Universal Benefit Plan Enrollment or Waiver Form
- 10. PenServ 403(b) Enrollment & Beneficiary Form

○ Background Clearances (Must Be Less Than 1 Year Old)

- 1. FBI Fingerprint Clearance (CHRI)
 - Enroll via IdentoGO with Code: 1KG6Q9
- 2. PA State Police Criminal Background Check
 - Apply via <u>PATCH</u>

- 3. Child Abuse Clearance
 - Apply via the <u>Child Welfare Portal</u>

B Health Requirements

- School Personnel Health Record Form
 - Includes: Physical Exam & TB Test
 - Download Form Here
 - Physical must be <1 year old; TB test no more than 3 months older than physical

Legal Disclosures

- Arrest/Conviction Report and Certification (Act 24/82)
 - Download Form
- Sexual Misconduct-Abuse Disclosure (Act 168)
 - One form per current/former employer where work with children occurred
 - Download Form

Training Requirements

- 1. Act 71 Training Suicide Prevention (Required for educators, support staff, and leadership)
- 2. Mandated Reporter Training (Act 31) <u>Recognizing and Reporting Child Abuse</u>
 - A completion Certificate must be submitted
